THE CHALLENGE

Heffernan Insurance Brokers (Heffernan) has been acquiring other companies as part of their growth strategy. Each acquisition has brought unique technology systems and data, adding complexity to Heffernan's overall IT landscape. They required an effective solution to integrate these diverse sources into a streamlined process for storage, usage, disposal, and reporting, ensuring a standardized experience for all customers and enabling the creation of meaningful, aggregated reports that could be used for informed management decision-making.

Heffernan aimed to understand the system load to identify potential bottlenecks, plan capacity effectively to prevent data loss and delays, and gain financial insights into data volume. They needed to profile data types, formats, transformations, and aggregations to ensure consistency, accuracy, and effective data management across all systems.

Addressing data quality issues were crucial for ensuring data integrity, completeness, and reliability, optimizing the data flow process for better performance.

THE SOLUTION

To support Heffernan Insurance Brokers' enterprise objectives and accelerate growth, Online delivered a solution to provide Heffernan with a comprehensive understanding of data acquisition, storage, and usage volumes and activities across different systems.

Stage 1: Extraction and Consolidation

The Online team extracted and consolidated data from multiple servers to facilitate a comprehensive analysis of the data flow across Heffernan's systems.

Stage 2: Data Cleansing

The data was then cleansed and transformed to ensure data consistency and quality.

Stage 3: Data Analytics and Reporting

Utilizing SQL Server and Power BI, and by leveraging advance analytics, a set of interactive dashboards were developed around data volume assessment, data profiling and data quality. These dashboards unlocked critical real-time insights on the data flows across the systems visualized through unified reporting across the organization.
